*The following two questions must be 'Yes' in order to submit a MOP Readiness Request.

PHASE 2 "MOP Language"

Requirements and Other Information

- NON-UCSD Email: Use this form if you do not have a UCSD Email address. (UCSD email version)
- Ladder-Rank Faculty. This form is for ladder-rank faculty interested in applying for a MOP Loan for your first purchase of your primary residence in San Diego County.
- Preliminary Questions: Both questions below* must be "Yes" to sumbit this form.
- Letter Required: A letter that includes MOP Language [aka Phase 2] is required. Letters include Proposal Letter, Letter of Intent or Offer Letter.
- Resource Letter: A Resource Letter is requested if applicable and available.
- Every Expectation Letter: This is required when the faculty appointment/start date is more than 30 days away.
- FHAP Website: Visit this website for additional information and details about MDP Office Hours.
- Submission Timelines: Visit this section of the FHAP Website to view quarterly submission open/close dates, selection timelines and other deadlines.
 Items with a red asterisk * are required.
- Iteritis with a red asterisk are required.
